AUDIT SUMMARY

Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of Benton County Fire Protection District No. 2 from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Credit card expenditures processes and procedures
- Review of credit card transactions
- Payroll disbursements
- Compliance with sale of asset

- General disbursements processes and procedures
- Review of general disbursement transactions
- Procurement for purchases

INFORMATION ABOUT THE DISTRICT

Benton County Fire Protection District No. 2 was formed in 1949 to provide fire protection services to the citizens of Benton County. The District's service area covers Benton City and the surrounding areas. The District has four full-time employees (District Secretary, Fire Chief, Maintenance Captain, Shift Captain) and fluctuating numbers of volunteers that administer its day-to-day operations.

The District is governed by a three-member Board of Commissioners. Board Members are elected to staggered, six-year terms. The District received revenue \$1,732,820 in 2014, \$1,676,431 in 2015 and \$1,527,729 in 2016. Approximately 65 percent of the District's revenue comes from property taxes.
