 - District operations: Operations and activities within the District are proceeding as expected with no significant issues to report.
 - Heavy equipment project: A heavy equipment initiative is upcoming, including scheduled dozer training and related preparations to ensure personnel and equipment readiness.
 - Demoss Road Fire: Approximately 3,000 gallons of water were utilized during the incident. The fire experienced a restart but was ultimately contained with no structure loss. The incident occurred within a wildland-urban interface area, and air support was requested and utilized during suppression efforts.
 - Radio communications issues: Challenges were identified during the Demoss Road Fire, including issues with DNR radio channels, which are currently being addressed. Additional concerns were noted with the SECOMM system, specifically related to a transponder recovery issue. These events highlighted areas for improvement in communication systems.
