FIRE CHIEF'S REPORT:

- LID Passed! We are working on a thank you for the community to be released in the very near future.
- National Night went very well. Good turnout.
- School starts on the 27th. We will be doing the "School Slow Down" the first 3 days in the AM.
- Benton City Daze is September 13, 14, 15. We are preparing for it. It will be the 3 full days. Street Dance is back in front of Patnodes. The Lawnmower races are back, and they will be at the fairgrounds.
- We are down 2 FF/PM positions. It has been posted and we have received 2 applications and several calls of interest. We will begin testing as soon as we have enough candidates. 1 candidate did a ride along.
- We held testing and have 2 new Volunteers and 1 new resident. We are still in need of 3 residents.
- We have 4 starting TCRA in September.
- Captain Pettis is much better and back to full duty.
- The Region is still pushing to get a new radio system, it will be a Motorola 800mhz system. The engineering has been done. The cost estimations are in the neighborhood of 18 to 30 million depending on the build out and what equipment the area decides to go with. Final numbers are aways out as the fine points are discussed.
- The basic road map to merge BCES & SECOMM is out. In short, the "leg work" has begun and in the near future it will be happening. The funding source appears to be a bi-county sales tax. The numbers and timing have not been finalized. More to follow as it becomes available.
